SUB: INTIMATION UNDER REGULATION 30 READ WITH SCHEDULE III OF SEBI LODR, 2015 REGARDING INTERIM APPLICATION FILED WITH HON'BLE NCLT PRINCIPAL BENCH, NEW DELHI FOR SEEKING DIRECTIONS FOR FINALIZATION OF THE FINANCIAL ACCOUNTS OF THE COMPANY FOR PERIOD ENDED MARCH 2020, JUNE 2020, SEPTEMBER 2020 AND DECEMBER 2020

Dear Sir/Madam,

This is inform to you that Atlas is a public limited listed company whose 57.88% shareholding is held by the public and 42.12% is held by the Promoters (Kapur family group). Since 2000, the company has suffered due to disputes between the promoter groups resulting in multiple litigations in various fora.

Presently, C.P. No. 18(ND) / 2015 has been filed by one Promoter group against Atlas under Section 241 – 242 of Companies Act, 2013 inter alia alleging mismanagement and oppression, which is at the stage of final arguments before Hon'ble National Company Law Tribunal, Principal Bench, New Delhi.

The same warring promoter group has refused to cooperate with the Board of Directors for finalization of the financial accounts of Sonepat unit of the company for the year/quarters ending on March 2020, June 2020, September 2020 and December 2020.

The Board of Directors have passed various resolutions, addressed several communications and issued show cause notices to the said promoter group but the same has not been heeded to. Therefore, the Board of Directors have been constrained to file an interim application on 03.03.2021 bearing filing reference no. 0710102027562021 in the same petition before Hon'ble NCLT seeking urgent directions to the Petitioners to cooperate with the Board of Directors for finalization of the financial accounts and hand over all necessary information to the Statutory Auditors for verification. The said application is most likely to be listed on 05.03.2021.
