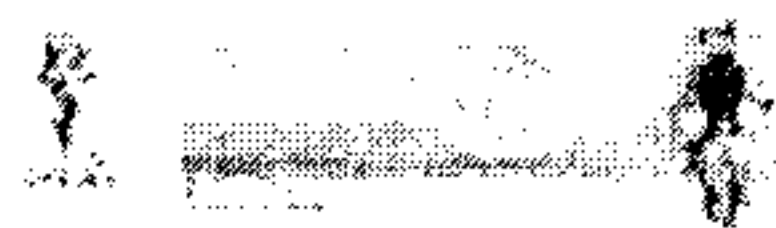

**Sub: Overdue in Credit Facilities**

We refer to our various telecalls/Personal visits/Mails for regularize your account including Adhoc facility of Rs. 4.00 Crore but till date we have not received any amount/ your response in the matter.

As you are aware, we have sanctioned the Adhoc of Rs. 4.00 Crore against firm order from Rajasthan government to the tune of Rs. 87.00 Crore. Despite your receiving the amount from Rajasthan government more than Rs. 75.00 Crore, you are yet to clear our Adhoc of Rs. 4.00 Crores given on 03.06.2017.


You are very well aware that the account will become NPA if irregularity/overdue remain more than 90 days. We are sorry to note that you have not cleared your overdue despite firm commitment given by Mr. Vikram Kapur on 28-11-2017 by 02.12.2017. Due to non payment of Adhoc amount of Rs. 4.00 Crore on due date, your account has now degraded to NPA category on 03-12-2017.

Another major concern is downgrading on your rating from ICRA B to ICRA D on 05-09-2017 due to delays by the company in servicing of its debt obligations and non routing of sales proceeds from our Bank's principal account in proportion of our share in the consortium.

We once again request you to kindly liquidate Adhoc of Rs. 4.00 Crore immediately and route your sale transactions through our Bank's principal account.
