In continuation to our intimation dated March 04, 2021 ,April 01, 2021, June 16, 2021 and August 12, 2021 this is to inform you that Hon'ble National Company Law Tribunal, Principal Bench, New Delhi vide its order dated August 26, 2021 has provided extension of four more weeks to the Promoters' Group and the Board of Directors of the Company for finalization of all pending financial results of the Company and to Comply with the Listing Regulations and save the Company from getting delisted from National Stock Exchange and Bombay Stock Exchange.

Further, the Hon'ble Tribunal, in the above said order dated 26.08.2021 extended its order dated 31.07.2021 by four more weeks and instructed both the exchanges (NSE & BSE) not to take any action for delisting of the shares of the Company till further orders.

Kindly take this order on your records and as directed by the Hon'ble Tribunal, please do not initiate any action for delisting of shares of the Company till further orders of Hon'ble NCLT.
