

दिल्ली दंगा : व्यक्ति पर घर में आग लगाने का था आरोप

# पहले दोषी को पांच साल की जेल

नई दिल्ली, 20 जनवरी (भाषा)।

उत्तर-पूर्वी दिल्ली दंगों से संबंधित मामलों में पहली सजा सनाते हए राजधानी की एक अदालत ने एक वृद्ध महिला के घर में आग लगाने के मामले में गरुवार को एक व्यक्ति को पांच साल के कारावास की सजा सुनाई और कहा कि दोषी का अपराध 'बहुत ही गंभीर' है। अतिरिक्त सत्र न्यायाधीश वीरेंद्र भट्ट ने 25 वर्षीय दिनेश यादव को पांच वर्ष के कारावास की सजा सुनाई और पीड़िता को मुआवजे के तौर पर 12,000 रुपए के भुगतान का निर्देश दिया।

अदालत ने छह दिसंबर को दिनेश को 73 वर्षीया मनोरी देवी के घर को 25 फरवरी. 2020 को आग लगाने वाली दंगाई भीड का सिक्रय सदस्य होने का दोषी पाया था। इस आदेश का व्यापक महत्व है,

क्योंकि यादव पहला व्यक्ति है जिसे उत्तर-पूर्व दिल्ली में हुए दंगों से जुड़े मामले में जेल की सजा सुनाई गई है। अदालत के आदेश के अनुसार, पीड़िता को हुए नुकसान के लिए दिल्ली सरकार से पहले कुछ मुआवजा मिला था। दंगों की घटना में उन्हें लगभग पांच लाख रुपए का नुकसान हुआ था।

अभियोजन पक्ष के अनुसार यादव दंगाई भीड का सिक्रय सदस्य था और वह 25 फरवरी की रात मनोरी नामक 73 वर्षीय महिला के घर में तोडफोड करने और आग लगाने वालों में शामिल था। मनोरी ने आरोप लगाया था कि करीब 150-200 दंगाइयों की भीड ने उनके घर पर हमला किया था, जब उनका परिवार घर पर नहीं था। इस दौरान दंगाइयों ने सारा सामान लुट लिया और भैंस तक भी अपने साथ ले गए। यादव

### 'भरपाई का निर्देश देना पूरी तरह अनुचित'

न्यायाधीश ने कहा कि दिनेश यादव को पीड़िता को कोई और मुआवजा देने या अभियोजन द्वारा किए गए 83,000 रुपए के खर्च की भरपाई करने का निर्देश देना 'पूरी तरह से अनुचित' होगा, क्योंकि यादव बेरोजगार है, उसके पास कोई संपत्ति या भुगतान करने की क्षमता नहीं है। अदालत ने सजा की अवधि तय करते समय यादव की कम उम्र, साफ अतीत और इस तथ्य पर भी विचार किया कि वह पहली बार अपराधी था। एएसजे भट ने कहा, 'बेशक, दोषी पहली बार अपराधी है और उसका अतीत साफ–सुथरा रहा है। इस बात का कोई सबुत नहीं था कि उसने सीधे तौर पर हिंसा की घटना को अंजाम दिया था। सजा की अवधि तय करते समय दोषी की कम उम्र को भी ध्यान में रखा जाना चाहिए।' विशेष लोक अभियोजक आरसीएस भदौरिया ने अदालत से दोषी को अधिकतम सजा देने का आग्रह करते हुए कहा था कि वह 'एक गैरकानूनी भीड़ का हिस्सा होने के लिए दोषी पाया गया, जिससे भारत की छवि बड़े पैमाने पर खराब हुई थी।' हालांकि, यादव के वकील ने न्यायाधीश से एक उदार सजा का अनुरोध किया, क्योंकि

उसने खद को संधार लिया था और एक साल से अधिक समय तक जेल में रहकर सबक सीखा था।

# दिल्ली में 40 फीसद सस्ती हुई कोरोना की जांच

जनसत्ता संवाददाता नई दिल्ली, 20 जनवरी।

दिल्ली सरकार ने गुरुवार को निजी गुजरा, पर खतरा टला नहीं अस्पतालों और प्रयोगशालाओं में कोरोना संक्रमण का पता लगाने वाली आरटीपीसीआर जांच की कीमत 300 रुपए तय की, इसे पहले की तुलना में 40 फीसद सस्ता किया गया है। इस बाबत दिल्ली सरकार की प्रधान सचिव स्वास्थ्य मनीषा सक्सेना ने आदेश जारी किए हैं।

अब तक निजी अस्पतालों और प्रयोगशालाओं में आरटीपीसीआर जांच के लिए 500 रुपए का भूगतान करना होता था। इसी तरह रैपिड एंटीजन जांच के लिए 100 रुपए का भुगतान करना होगा, जिसके लिए अब तक 300 रुपए तक लिए जाते थे। आदेश के मृताबिक कोरोना जांच और घर से नमूने एकत्र करने के लिए पूर्व के 700 रुपए के बजाय 500 रुपए का भूगतान तय किया गया है।

स्वास्थ्य विभाग ने सभी निजी अस्पतालों और प्रयोगशालाओं को 24 घंटे के भीतर संशोधित कीमतों के बारे में जानकारी प्रदर्शित करने का निर्देश दिया है। वहीं, सरकारी केंद्रों और अस्पतालों में आरटीपीसीआर और रैपिड एंटीजन जांच निशुल्क किए जाते हैं।

'तीसरी लहर का चरम

जनसत्ता संवाददाता

नई दिल्ली, 20 जनवरी।

दिल्ली के स्वास्थ्य मंत्री सत्येंद्र जैन ने गुरुवार को कहा कि दिल्ली की तीसरी लहर का चरम संभवतः गुजर चुका है। हालांकि उन्होंने आगाह किया कि दिल्ली अभी खतरे से बाहर नहीं आई है। उन्होंने कहा कि सक्रियता के साथ किए गए उपायों के चलते मामलों में कमी आई। इसके अतिरिक्त प्रतिबंधों में ढील पर फैसले के लिए पहले स्थिति का विश्लेषण करना होगा।

दिल्ली में हाल ही में कोरोना संक्रमण के दैनिक मामलों में भारी वृद्धि उछाल देखने को मिला था, जब एक दिन में 28 हजार से ज्यादा मामले सामने आए थे। इस वजह से संक्रमण दर भी बढ़कर 30 फीसद के पार चली गई थी। उन्होंने कहा कि इस उछाल को कोरोना संक्रमण की मौजुदा लहर का चरम माना जा सकता है और ऐसा लगता है कि इस लहर का चरम गुजर चुका है। बीते कुछ दिनों में रोजाना दर्ज होने वाले नए मामलों में गिरावट आई है।


