### NOTES TO THE FINANCIAL STATEMENTS

#### 1 Corporate Information

Atlas Cycles (Salt babat) Limited (" Company") is a Public incorporated on 28 May 1999. It is classified as Nongovt company and is registered at Registrar of Companies, Delhi. Its authorized share capital is Rs. 500,000 and its paid up capital is Rs. 500,000.

#### 2 Significant Accounting Policies

### 2.1 Statement of compliance

Practorizance with the notification issued by the Ministry of Corporate Affairs, the Company has adopted indian Accounting Standards (referred to as "Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015 with effect from Apr 1, 2016. These are the company's first Ind AS financial statements. The date of transition to Ind AS is April 1, 2016. In accordance with Ind AS 101 First Time Adoption of Indian Accounting Standard, the company has presented a reconciliation of shareholder's equity as at Mar 31, 2017 and 1° Apr 2016, form the presentation of financials under previous SAAP to IND AS.

#### 2.2 Basis of Preparation

These financial statements are prepared on historical cost basis, except for certain financial instruments which are measured at fair values as explained in the accounting policies below.

# 2.3 Critical accounting judgements and key source of estimation uncertainty

The preparation of the financial statements requires management to make est mates and assumptions that affect the reported amounts of revenue, expense, assets and liabilities and disclosures relating to contingent liabilities on the date of the financial statements. Actual results could differ from those estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revision to accounting estimates is recognised in the period in which the estimate is revised and in any future period affected. Key source of estimation uncertainty which may cause material adjustments:

#### 2.3.1 Revenue recognition

Finance income for service concession arrangement; under finance assets model is recognised using effective interest method. Revenue from operations and maintenance services are separately recognised in each period as and when services are rendered.

Interest income is recognised on time proportion basis taking into account the amount outstanding and the rate applicable.

Dividend income is recognised when the shareholders right to receive payment has been established.

#### 2.3.2 Income-tax

Income tax expense comprises current tax expense and net change in the deferred tax assets or Lability during the year. Current and deferred tax are recognised in profit or loss, except they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

2.4 Provisions

Provisions are recognised when the company has present obligation (legal or constructive) as a result of a past event for which reliable estimate can be made of the amount of obligation and it is probable that the company will be required to settle the obligation. When a provision is measured using cash flows estimated to settle the present obligation its carrying amount is the present value of those cash flows; unless the effect of time value of money is immaterial.

# 2.5 Financial assets and financial liabilities – subsequent measurement

# Financial assets at amortised cost Share capital

Financial assets are subsequently measured at amorbsed cost if these financial assets are held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are sololy payments of principal and interest on the principal armount outstanding.

# Financial assets at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

# Financial assets at fair value through profit or loss

Financial assets are measured at fair value through profit or loss unless it is measured at amortised cost or at fair value through other comprehensive income. The transaction costs directly attributable to the acquisition of financial assets and liabilities at fair value through profit and loss are immediately recognised in statement of profit and loss.

investment in subsidiaries is carried at cost in accordance with ind AS 27 - Separate Financial Statements

### Cash and cash equivalents

The company considers all highly Equid financial instruments, which are readily convertible into known amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consist of halances with panks which are unrestricted for withdrawal and usage.

#### Financial liabilities

Subsequent to initial recognition, these liabilities are measured at amortised cost using the effective interest

### 2.6 Earnings per share ('EPS')

Basic EPS are computed by dividing profit or loss attributable to equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. Diluted EPS is computed by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares considered for deriving basic EPS and also the weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares. The dilutive potential equity shares are adjusted for the proceeds receivable had the equity shares been actually issued at fair value (i.e. the average market value of the outstanding equity shares). Dilutive potential equity shares are determined independently for each period presented.

The number of equity shares and potentially dilutive equity shares are adjusted retrospectively for all periods presented for any share splits and bonus shares issues including for changes effected prior to the approval of the financial statements by the Board of Directors.

### 3. First-time adoption of Ind AS

These are company's first condensed financial statements prepared in accordance with IndiAS. The accounting policies set out in note 2 have been applied in preparing these financial statements for the year ended March 31, 2018 and comparative financial statement for the year ended March 31, 2017 and the balance sheet as at Apr 1, 2017 and in preparation of opening IndiAS balance sheet at January 1, 2017 (the date of transition).

in preparing its opening balance sheet, the company has adjusted the amounts reported previously in financial statements prepared in accordance with the accounting standards notified under Companies (Accounting Standards) Rules, 2006 (as amended) and other relevant provisions of the act (previous GAAP or Indian GAAP).

An explanation of now the transition from previous GAAP to Ind AS has affected the company's financial position, financial performance and coshflows is set out in the following tables and notes.
